**SPORTING OR ATHLETIC RELEASE AND WAIVER OF LIABILITY
ASSUMPTION OF RISK AND INDEMNITY AGREEMENT** (sporting)

IN CONSIDERATION of access to and participation in any Loyal Corn Festival activity (the "Event") hosted by the Loyal Corn Festival (the "Host"),

EACH OF THE UNDERSIGNED, for himself/herself, his or her personal representatives, heirs, and next of kin:

1. HEREBY WARRANTS AND REPRESENTS that: (i) he or she understands that the particular activities which he or she may undertake involve vigorous physical exercise, including by way of example running, sports activities, and prolonged or peak physical activity, (the "Activities"); (ii) he or she understands that there are significant risks associated with participation in the Event and the Activities, including by way of example the possibility of serious injury or death caused by falling, exertion, or physical activity; (iii) he or she understands that the Activities may or may not be supervised by the Host's employees or agents; (iv) he or she understands that emergency care may not be immediately available in the event of an injury or health event during the Activities at the Event; and (v) he or she is in sufficient physical condition and is physically able to undertake all Activities related to the Event; has no disability, impairment or ailment preventing him or her from active or passive exercise, or that will be detrimental to his or her health, safety, comfort or condition if he or she does so engage or participate.
